

## Non-governmental non-profit state organizations in Kashkadarya

**Abstract:** This article contains information about non-governmental non-profit state organizations in Kashkadarya.

**Keywords:** non-state, non-profit, sport, legal aid, charity, citizens, action

Non-governmental non-profit organizations can be formed to achieve social, charitable, cultural-educational, political, scientific and management goals in the field of health protection of citizens, development of physical education and sports, satisfaction of spiritual and other non-material needs of citizens. It is formed to protect the rights and legal interests of citizens and organizations, to resolve disputes and disputes, to provide legal assistance, as well as for other purposes aimed at achieving the public interest. is an organization aimed at achieving goals.

In the KRE, a non-profit organization is a legal entity that does not have the main purpose of profit and does not distribute the profit among the participants. Article 2 of the Law on NTT of the Republic of Uzbekistan defines this term as follows: "Non-governmental non-profit organization - It is a self-governing organization established by individuals and (or) legal entities on a voluntary basis, which does not make income (profit) the main goal of its activity and does not distribute the received income (profit) among its participants (members). It is established to protect the rights and legal interests of individuals, other democratic values, to achieve social, cultural and educational goals, to satisfy spiritual and other immaterial needs, to carry out charitable activities and for other socially useful purposes. all conditions are being created for organizations to operate. As a result, their number is increasing year by year, and their fields of activity are also expanding. In 1991, there were about 100 NGOs in the country, and now there are 9,478. In addition, more than 2,000 religious organizations belonging to 16 religious denominations and 235 permanent arbitration courts are registered with the judicial authorities. 715 judges are working in them.

Non-governmental non-profit organizations cover various areas of socio-economic, cultural and educational spheres, in particular, entrepreneurship, sports development, environmental protection, social support of disabled persons.

If we pay attention to the role of NGOs in creating jobs, as of February 1 of this year, more than 55,000 employees, of which more than 21,000 are working on a public basis. Also, more than 20 million citizens are members of various NGOs. For example, the Youth Union of Uzbekistan has more than 10 million members, the "Youth" physical education and sports society has more than 3 million members, and the trade union of employees of the agro-industrial complex of Uzbekistan has almost 2 million members. According to the information received from the Ministry of Justice according to that, more than 1 trillion 864 billion 358 million soums were deposited into the accounts of NGOs last year. These funds are used to solve socially important issues in local areas. In particular, 345.6 million soums of material aid and 117.1 million soums of medicines were purchased for 2,224 lonely, disabled, low-income elderly people. About 40,000 citizens were trained on the topic of proper movement and preparation in emergency situations. 48 endocrinology rooms were equipped in the Republic of Karakalpakstan, Samarkand, Andijan, Navoi, Fergana, Kashkadarya and Tashkent regions, 612 people

general practitioners and 156 specialists were trained, more than 954,000 people belonging to the risk group underwent free screening.

During the II quarter of 2022, the Kashkadarya regional justice department carried out a number of activities in the field of conducting state policy in the field of development of the activities of non-governmental non-profit organizations, helping to organize their cooperation with state bodies and organizations.

By the end of the reporting period, the total number of non-governmental non-profit organizations is 570, of which 371 have the status of a legal entity, and 199 are separate units of non-governmental non-profit organizations that do not have the status of a legal entity. The number of religious organizations is 187, of which 185 are Islamic and 2 are non-Islamic religious organizations. During this period, the department received 1,126 letters and documents, of which 90 were controlled, and 1,036 were rejected. 'taken as information. 14 letters and documents came from the Ministry of Justice as a letter of assignment. 88 of the controlled letters and documents were executed on time, and 6 remained outstanding at the end of the reporting period.

8 non-governmental non-profit organizations were deregistered from the state register and 17 non-governmental non-profit organizations were re-registered by the non-governmental non-profit organization department. Also, 1 permanent arbitration court account was registered. During the reporting period, the department received 44 appeals (20 applications, 24 complaints), 10 of which were satisfied, 30 legal clarification was provided, 3 appeals were sent for substantive consideration, 1 appeal remained.

The department submitted a total of 248 submissions, 94 warnings, and 66 proposals for administrative prosecution. As a result, 52 persons were brought to administrative responsibility, 223 persons were brought to disciplinary responsibility based on Article 181 of the Labor Code of the Republic of Uzbekistan. During the reporting period, the department conducted 106 monitoring and 46 studies.

According to the results of the conducted monitoring, a total of 658 cases of violations of the law were identified, and 48 reports were made in order to prevent these cases of violations of the law and not to repeat them in the future. mobile reception is organized. Open communication was established at mobile receptions, and opinions were exchanged on the problems that plague organizations. During this period, the department organized a total of 80 promotional events, including 7 times on television, 10 times on radio, 11 times in newspapers, 21 Several times, speeches were made on the website and other electronic media. 10 lectures, 11 roundtable discussions and 9 seminars were organized in neighborhoods, labor unions and other places, 1 demonstration manual was prepared and delivered to more than 120 organizations in electronic form..
